Recital Fee    \$18 per performer.

Your payment not only pays for the lessons but also reserves your time slot and space in the Accelerated Piano Program. It is based on enrollment, not attendance. We usually have an average of 4 60-minute lessons per month. On some months we will have 5 lessons, and on others 3 due to some major holidays and school breaks. These are included in the flat rate monthly tuition.

2. Rates and fees are subject to change at any time; however, the instructor will make every effort to notify client of rate changes in writing at least one month in advance.

**Policies:**

1. Client must pay all fees, as outlined in rates section above, for the whole month, before the first lesson of each month. An invoice will be sent toward the end of each month for the following month. If a payment is 10 days overdue, lessons will be suspended until payment has been made in full.

2. Lessons are ongoing. Missed lessons will not be made up. The student may reschedule up to one lesson per month with a minimum of 24-hour notice and if there are available openings in the Accelerated Program. Only in the case of a sudden illness the student may reschedule their lesson as late as 4 hours before the lesson. All rescheduling is done conveniently through our student portal. Frequent cancellations of any kind may result in student's removal from instructor's roster and loss of student benefits.

3. Two weeks or 14 calendar-day notice is requested for students dropping out of the studio for any reason, or for taking a break. If a student decides to take a break from lessons, they will be put on the waiting list and contacted when an opening is available.

4. Client accepts all liability for any damage to his or her person or property, as well as that of his or her children or guests, while studying or performing at Rosie Mace's Home Studio and releases Advance to Music and its proprietor, Rozalia /Rosie/ Mace, from all liability related to such damage.

5. Pictures and videos of my students may be posted on my studio website or included in studio publications with only first name, or no names attached. Please check one of the options below to grant or withhold permission.

**Expectations:**

1. The study of music requires time, practice, and dedication. For this reason, students and their parents or guardians are expected to carefully follow the recommendations of their instructor. Any deviation from these recommendations may cause negative results, which may not be construed as the responsibility of instructor or the result of instructor's lessons.
2. Students are expected to spend a reasonable and consistent amount of time studying with instructor before assessing lesson results. No assessment of the quality or effectiveness of lessons may be made prior to one quarter, or three months, of consistent weekly lessons.
3. Students of music are expected to keep themselves in good health and to be considerate of the health of the teacher and the health of other students.
4. Students may be required to purchase instructional and performance items, such as but not limited to books, worksheets, stave paper, metronomes, instruments, practice. Failure to purchase necessary materials may hinder progress.
