Dear Advance to Music Families,

Welcome! I am so glad you are here. Registering for lessons is an agreement to the studio policies, so please read through them carefully.

Studio Lesson Schedule:

Our calendar contains 47 learning experiences throughout the year. Lessons are 60 min. each and are held weekly and year-round unless otherwise specified on the studio calendar. Studio breaks have already been accounted for in the cost of yearly tuition. You are not charged for the days the studio is closed. In addition, we are excited to announce:

Recitals:

We have two piano recitals each year. There may be a small Recital fee for each performer depending on the venue. Participation is optional but always encouraged! (See calendar.)

Tuition:

Annual tuition covers 47 learning experiences and is divided into 12 equal installments of \$150/mo. This amount remains the same regardless of the number of lessons taught in the month. Your tuition not only pays for the lessons but also reserves your time slot and space in the Accelerated Piano Program. It is based on enrollment, not attendance.

Each family must enter their payment information into their My Music Staff (MMS) account. Tuition amounts will be withdrawn via automatic payments on the 1st of each month. There is no fee for paying through automated checking account withdrawals (ACH). All payments are processed directly through Stripe. A 3% convenience fee will be applied for all credit/debit card transactions.

After the 10th of each month, accounts remaining past due will be charged a \$15 late fee.

Attendance:

Your lesson time is reserved just for you! If you cannot attend, I kindly ask that you cancel your lesson on your My Music Staff Account. Then, feel free to register for our BONUS lessons. Missed lessons cannot be made up. As a courtesy, you may reschedule 1 lesson every 2 months if there is an available opening in the Accelerated Program. To do that you need to cancel your lesson at least 24 hours in advance through our student portal. Then, you can sign up for your child in any available Accelerated Program class. Your rescheduling credit will expire if not used. Rescheduling is offered as a courtesy when possible and is not guaranteed.

If I am unable to provide a lesson at your scheduled time an alternate lesson time will be offered. If I decide to take an unscheduled break during the Summer, your fee for that month will be prorated. – you will not be charged for the missed time.

Discontinuing Lessons

If you need to withdraw for any reason, notice must be given in writing to rosiemace@advancetomusic.com 30 days before the next billing cycle. (i.e., If you choose to cancel in Feb., notice must be provided by Jan.1st.)
